What Types of Cookies Do We Use?

We categorize cookies as follows:

By ownership:

- First-party cookies: Set by Clarity AI directly.
- Third-party cookies: Set by external services (e.g., analytics providers).

By lifespan:

- Session cookies: Deleted when you close your browser.
- Persistent cookies: Remain for a specified period (see table below).

By purpose and legal basis:
